In patients with atrial fibrillation, thrombus formation in the left atrial appendage (LAA) can result in cerebral and/or peripheral embolization, often with disastrous results. For many years, systemic anticoagulation with oral warfarin was the mainstay of treatment. But things have changed. Newer procedures, newer devices and novel anticoagulants have altered the therapeutic landscape. Attendees will discuss the types of atrial fibrillation, the anatomy of the LAA and the therapeutic options available for patients who wish to avoid or cannot tolerate systemic anticoagulation. We will discuss the role of primary and adjunctive surgical procedures (internal/external occlusion or formal excision) as well as percutaneous (pericardial and intracardiac) approaches and their associated devices.

In its stead, we now have the Merit-Based Incentive Payment Program System (MIPS). Due to begin in 2017, MIPS consolidates numerous federal reporting/incentive programs.
