Dear Chairs and Ranking Members,

We, the undersigned organizations, are writing in support of U.S. global health aid that focuses on the frontline delivery of healthcare services. By "frontline" we mean delivering services directly to patients.

Frontline health workers include providers at all levels from physicians to community health workers. Necessary support for these workers includes training, supplies, protection, and supportive supervision.

Frontline health workers make our country safer by detecting and dealing with emerging health threats before they reach our shores. They are vital to our national health security.

Our request does not call for increased spending. It calls for shifting existing resources from overhead and unessential upstream activities to the frontlines.

Recent report language in House and Senate appropriations legislation calls for more attention to frontline health workers, and we ask that you require the Administration make that support more transparent with the report language below. The language below directs the Administration to provide an estimate for each Global Health Program of the amount of current spending on these workers and a target for increasing that amount.

The House and Senate State and Foreign Operations subcommittees of Appropriations included FY24 and FY25 report language paragraphs titled "Frontline health workers" and "Global Health Workforce", respectively. We request that you continue that language for FY26 with the addition of this paragraph:

"The Secretary of State shall report, not later than (x) days after the enactment of the act, for each program in the Global Health Programs table above:

- 1. The estimated amount of program funds spent in the most recent fiscal year for which data is available on support provided directly to frontline primary healthcare workers, including for training, supplies, protection, and supportive supervision.
- 2. The report shall include targets for increasing the amount of spending on these activities in the next two years."
